Legal Calendar Evaluation

Sharing session on the Use of Legal Calendar

To reflect the changes and experiences of using the Legal Calendar from LIWG members, the secretariat organized the sharing session on lessons learnt and experiences on using legal calendars to disseminate legal knowledge on land and natural resources to communities.

In the discussion, members shared on how the legal calendar has changed and evolved over the past 10 years, strengths and weaknesses (successes and challenges) of the project and how to strengthen the project and make it as effective as possible.

Many thoughts and stories were shared in the meeting which could be put in the plan to improve the use of the legal calendar, especially to have more trainings on how to use and disseminate laws and regulations from legal calendar to community to ensure that they understand how to use it. A highlight during this session was the role play by members to show how they delivered knowledge on the legal calendar to partners and as well as to communities.

Some reflections from the evaluation of the legal calendar were also shared with participants in the meeting.

Training on development case study related to land issues

Working in different communities, LIWG members have many stories to be told. In order to provide skills to members to frame stories in the way that they can be shared with different audiences, LIWG organized the training for some LIWG members on the development of case studies related to land issues including a socio-economic approach.

For this training, we were happy to have external trainers who have experience on capturing stories related to land issues in the Mekong region to provide skills and tips for our members.

Throughout the 3-day period of learning, all participants developed the template that they can use to collect stories based on the context in different communities.





The LIWG annual general meeting

To present the work the secretariat has done in the year 2019 and the plan for 2020 to the core members, the Annual General Meeting (AGM) was organized.

In the meeting, we presented our main achievements, the challenges we faced as well to share back our evaluation survey results on the work of the network.

In this meeting, the LIFE project, as a LIWG network initiative, updated about their work and their plan for a series of coaching on land and natural resources for Lao CSOs and their government counterparts.

To help the secretariat better understand members' interest to work together in some thematic areas, a World Café about LIWG thematic work was organized for members to discuss several potential thematic areas such as gender, responsible investment and policy advocacy. From the group discussion, members provided key recommendations on the need and options for working on the selected thematic areas which was shared to members via email for the result of the discussion.

The meeting also discussed the need to elect 3 new members to join the steering committees to replace some members who have left.

Provincial Networking: Jhai Coffee Cooperation

In early March of this year, to strengthen the relationship with member organizations in the communities, , the LIWG secretariat visited Jhai Coffee Cooperation in Paksong who is supported by our member, <u>DGRV</u>- German Cooperative and Raiffeisen Confederation. Our visit was to learn how Jhai Coffee Cooperation is working and supporting the local community on coffee production as well to explore their relation to land.

From our visit, we learned that DGRV provided a wide range of training and capacity building to the members in the cooperative as well as to enhance their network with the coffee groups in another Asian country.

Jhai Coffee Cooperation is working with young people in the community to build up the new generation to promote local coffee production. So they set up the youth center, a space for young people to learn about coffee and adding value to coffee production.





With support from the <u>Lao Farmer Network</u> (which was coordinated by CLICK – a LIWG member), youth members from Jhai Coffee Cooperation have the chance to increase their knowledge and skills and so they are more confident to be young entrepreneurs, adding value to coffee production which their parents are involved in.

Lots of work to better structure the administration and finance of LIWG

Starting with the year 2020, the secretariat spent time to reorganize the administration and finance to have a better structure. The team, taking the results from the AGM into consideration, reflected on what were successes and challenges in the past year to identify areas and steps to improve.



LIWG involved in Voice project

As part of the project together with LIFE and Stella on to 'Empower youths with ethnic background to become agent of change in protecting land rights in their communities', LIWG played a key role to capture stories of several youth who have joined in different activities within this project. All stories, including article, publications, photos and videos, will be posted on LIWG social media and website as well as shared with LIWG members through internal communication channels.

LIWG's Initiatives and members LIFE project

LIFE Coaching on Legal Calendar

To enhance the capacity of field staff of CSOs and local authorities on the use of the Legal Calendar, the LIFE team organized two coachings to provide facilitation skills for field staff from 3 organizations: JVC in Savannakhet province, CCL and SAEDA in Oudomxay province, all of them being LIWG members, who were jointly trained with their government counterparts.

This coaching was based on the 6 topics from the Legal Calendar 2020 by using the interactive LIFE approach including games, role play, group discussion, posters, SMART, Bloom, PMI and the River Of methodologies.





These methodologies helped participants to learn more on the content of the Legal Calendar 2020 and how to use this content in their work, especially when they do dissemination in the communities.

After the coaching, all participants applied the skills they learned in a 1-day activity at village level in their target areas.

Voice Project: Empower ethnic youths to become agent of change in protecting land rights in their communities

This project on dissemination of tools and methods on how to preserve land and natural resources is supported by Voice, (funding from the Ministry of Foreign Affairs of the Netherlands and supervised in Lao PDR by OXFAM) and implemented by <u>LIFE project.</u> <u>LIWG and Stella</u>. 10 youths, from various ethnic backgrounds, from the Faculty of Law and Politics, National University of Laos and their 10 peers in the home villages have joined this project.

The project has a duration of 15 months (July 2019-September 2020) with the goal to enable youth to become agents of change in their villages in the planning of the use of natural resources. The idea is to teach youth on the respective laws and regulations related to natural resources and land and empower them to have a stronger voice in their village when it comes to natural resources use.

The preparatory workshop on soft skills and Community Dialogue Facilitation was organized to build capacity for the 10 youths in Vientiane in November 2019 to obtain skills before leading activities in their communities. This workshop was led by <u>Stella</u>.

The 'River Of' activity led by young people in villages

The intergenerational dialogues between youth and their village communities took place from 24th January - 12th February 2020. The 10 youths took the lead to implement the activities at their villages. They spent 1 day to organize the intergenerational dialogue by using the 'River Of' activity as the tool for learning. The goal was to find out the changes and problems that arose in the villages within the last 5 to10 years from natural resources use and destruction.

This was the first time for this young group to lead the activities to discuss about the change of natural resources in their communities.

The reflection workshop for the result of activities from villages

After implementation of activities in their villages, all youth participants shared back what they learned from their own villages among the youth group, so everyone could learn from each other. In a next step, the youth will learn about mitigation techniques and the respective laws to tackle problems in their villages and prepare a role play for their communities.

Youth group and LIFE team sharing their works to Voice Grantees

As part of a **sharing session of Voice grantees** organized by Click under the Community of Practice (CoP) on youths, representatives of youth group together with the LIFE team shared their experiences among Voice grantees who came to visit them. This was a good opportunity for the youth group and LIFE team to share what they had done under the Voice grant in order for grantees to learn from each other and also for LIFE and youths to share tips and methodologies they used in the activity implementation.

Legal Calendar launching in Savannakhet by JVC

This launching was to introduce the importance of the legal calendar 2020 to key government counterparts before doing dissemination to local communities in the target areas. In the meeting, all participants shared comments and suggestions to legal calendar which could be put in the consideration to improve the work of the legal calendar better.

There were also representatives from MONRE and the task force team of the legal calendar attending this launching. JVC is one of our members who is active in using the legal calendar to disseminate legal knowledge to communities especially in the part of using and protecting natural resources.

Multiple stakeholder Dialogue on Improving Natural Resource Governance and Climate Change Adaptation

To enhance the capacity of local authorities, Lao CSOs and Community Based Organizations (CBOs) on good natural resource governance especially on land and forest, <u>Green</u> <u>Community Alliance</u> (GCA) organized the workshop on 'Multiple stakeholder Dialogue on Improving Natural Resource Governance and Climate Change Adaptation' in the end of the year 2019 in Northern Agriculture and Forestry College (NAFC), Lungprabang province. The two-day workshop provided a place to reflect on the collaboration between local authorities and Lao CSOs and CBOs to promote and implement activities on good governance on land and forest in the community level.

The workshop included the sharing session with a wide range of topics related to natural resources with guest speakers from Souphanouvong University, local authorities and Lao CSOs. The workshop also included the study trip for all participants to visit Pak Seung campus to learn about organic farming practices and the agroforestry concept. Students from Souphanuvong university also joined the workshop.




Some highlights from LIFE project for CoP 2019
