Majority of landownerships in the development project area belong to individuals. When development projects will take place, prior compensation for the loss of land, houses, etc. to affected people are necessaries before starting the projects. It is important to ensure the fairness to affected people. If projects have not had budget to cover compensation to affected people in the project area, they should be allowed to continue to live or do the cultivation there. For this case, project owner should not take the land without a certain timeline.

This launching event aimed to present the topic of legal calendar 2021 to public to understand better for the meaning of each topic and how those topics link to laws related to land and natural resources in Laos. In this event this year, the taskforce members also presented the process of development legal calendar to audiences and share experiences on the use of legal calendar in the community levels.

For this year's launching event, there were representatives from different faculties from NOUL, government partners, Civil Society organizations (who are LIWG members) and partners attended this event.

 - Oustomary land rights
 - Land registration and land titling
 - Participatory in land lease and land concession
 - Land conflict resolution
 - Participatory Conservation Forest protection and Management
 - Protection and sustainable use of forest products
 - The impacts from the chemical use and reduction mitigation

There were many guests from different organizations from government partners in the central and local levels, National University of Laos and LIWG members attended this event.

This event did not just to present the result from this study to participants, but there were also sharing experiences from local government about their raising awareness works on women and land rights in local levels as well as the challenging each face.

Interactive learning and sharing lesson on land, forest, natural resources



To create the space for staffs from CSOs and INGOs and officials to learn and share the lessons learnt and improve the cooperation for more effective of work outcomes on land and natural resources in Laos, on 12th November 2020 LIWG secretariat organized the yearly interactive learning and sharing lesson on land, forest, natural resources and environment in Vientiane.

The presentation from Department of Land on the land law dissemination and the development of sub-legislation was the highlight of the discussion, especially on the plan to disseminate and how to ensure people can access to land law in the understandable way that can help to protect their rights over their land.

In addition, there was also the sharing on the study report on the impact of Covid-19 to agriculture and food security as well as the introduction topics of Legal calendar 2021 to participants in this session.

There were representatives from government partners and LIWG members organizations joined this event to share and had discussion on topics presented in this sharing session to collect idea for further work, partnership towards contribution to the more sustainable socio-economic development.

LIWG Core members meeting

On 13th November 2020, LIWG secretariat organized core meeting to share the key achievement and update the process of network's work as well as up-coming activities.

In the meeting, LIFE, Stella, CLE and LIWG secretariat together with youths who joined project shared the result of Voice project on Empowering ethnic youths to become agents of change in protecting land rights in their communities to LIWG members and partners (More about this please continue to read in the session below in the LIFE project).

Highlight topics were also presented and shared in the meeting. A presentation of LIWG Reserve Fund presented by committee to members aiming to strengthen the sustainability of the secretariat. In this meeting, the chair also invited members who are able to contribute towards this reserve fund to coordinate with secretariat. This is the continuous topic and it will continue to be discussed about this with members.

The meeting also had a sharing from LIWG committee about world bank project on project of Public Information and Awareness Services for Vulnerable Communities in Lao PDR. This project is under discussion and secretariat will announce to members after the final process.

To understand more about gender in the area of natural resources, LIWG secretariat invited its member, <u>SODA</u>, a NPA, to share the keys findings of their gender study to participants in the meeting.

From sharing from SODA and the study on women right lands that LIWG commissioned, the group discussion was organized in the meeting to continue discussion about member's works on gender issues and to share challenging each face, especially in the remote areas. This discussion was important for members to learn from each other about experiences and providing suggestion to each other to address the challenging regarding to gender issues.



The good practice: Legal Calendar as the learning tool on land and natural resources

To capture the good practices of the LIWG on land rights advocacy and learning to share with <u>Bread for the World</u> (BftW)'s partner organizations from Southeast Asia and the Pacific, LIWG secretariat in supported by its members to produce video on the use of Legal Calendar as a good case study of LIWG and it's funded by BftW.

The video is in the final process and will be shared also to LIWG members and partners.



LIFE Project

LIFE coaching for partners

From October - December 2020, LIFE team continued to organize numbers of coaching to its partners both civil society organizations, non-governmental organizations and development partners such as GIZ Laos, Cord Laos, Department of Lands of MONRE, DALaM of MAF and provincial and district counterparts.

The coaching included advanced and basic curriculums which covering areas of recognizing of customary land tenure and communal land titling; basic rights of Lao citizens on Land and land conflict resolution.

After each coaching, participants in the coaching did pilot activities in target villages and they applied skills, methodologies and information from the coaching to deliver to villagers. In each pilot village, local officials and organization staffs led activities.

From reflection of the coaching, LIFE sees that most of participants are very active and they can learn to use methodologies effectively especially, women who could lead and explain content of each topic to villagers very well. One of the highlight from coaching was that the pilot activities in the villages were run by ethnic languages such as Khmu, Pong and Hmong and this is very important to ensure that local people understand laws in their own languages.

Voice Project: Youth Sharing Experiences Workshop on Empowering ethnic youths to become agents of change in protecting land rights in their communities

To create the opportunity for youths who joined the project to share experiences and the result from the project implementation, LIFE, LIWG, Stella and CLE organized the sharing experience workshop on Empowering ethnic youths to become agents of change in protecting land rights in their communities to LIWG members and teachers and students at Faculty of Laws and Politics to learn about their involvement in the project after one year-implemented project.

On 12th November 2020, youths shared experience with more than 150 students and professors from Faculty of Law and Politics, CLE in Vientiane and Champasack and other related faculties from National University of Laos. There were many interesting tools prepared by youths to demonstrate in this event including: heart head hand (tool for facilitation), River Of, games and role plays to explain about issues and laws. In this event, youth performed two role plays related to the situation in their villages namely: land grabbing and health issue because of using chemical in agricultural activities.



On 13th November 2020, the event was organized to share the result of the project LIWG members, partners, and donors. This sharing event was organized in the interactive way which participants could talk and discuss closely with youths who joined the project. In the panel discussion, representatives from organizations and youths who involved in this project discussed and answer questions from participants, especially about the lesson learn and the future plan of youths that they would like to continue their efforts to be part in improving the environment in their communities to be better.

A lot of university students expressed their interests in participating in this project if there is next phase. In addition, there is also a strong expression from professors that they are interested in supporting their students to such opportunities.



Participants praised for the achievement from implementing this project, especially to youths who could lead activities in their communities very well and get positive feedback from their own communities.



The government approves the sale of land along either side of the 450 Years Road in Vientiane

93 plots of land within 50 meters along both sides of the 450 Years Road, will be sold off at market rates with the aim of raising funds to repay the Bank of the Lao PDR for the road's construction.

Authorities discover concessions granted on state land in four provinces without evidence of formal agreements

According to a report by Mr. Bounthong Chitmany, the inspection authority found state land had been leased on behalf of the government in Phongsaly of 112 projects, 13 projects were uncovered that had duplicate names. In Luang Prabang of 24 projects, only 23 projects were officially registered. In Sekong, it discovered three projects without an official concession. And in Attapeu, 11 projects operated without proper concessions.

The government gives licenses for mining exploration in the area around 7 million hectares, covering of 30.75% of country's area

Since 1990, Laos has opened the door for foreigner companies to invest in the mining sector. To date, 214 companies have been given exploration contracts by Lao government. With that, 21 companies are under prospecting, 70 companies are in the process of exploration, 43 companies are under feasibility studies; and 80 companies are operating and extracting.


Lao government gave green light for 31 dam projects in Saysomboun province
