#### **Community of Practice on Women Land Rights in Phongsaly**





The WLR-CoP conducted a 3-day coaching visit to World Renew in Phongsaly. The purpose of the visit was to coach the WR team and its partners to empower women towards their land rights by using the LIWG awareness raising toolkit on WLR so that their awareness and understanding of land rights. After a refresher training completed, the team visited the LaoSeng and Akha communities in Ban Chomchaekao and Ban Chomchaemai. Debriefings refined the approach for future visits, ensuring continued impact in the Akha village of Ban Chomchaemai. This collaborative effort equipped women with knowledge and confidence to participate meaningfully in local land governance, paving the way for a future where their land rights are recognized and respected.

#### Community of Practice Focal group on Responsible Agriculture Investment Meeting

The LIWG Responsible Agriculture Investment Community of Practices (RAI-CoP) convened on 9 October 2023 to chart a strategic course for the future and warmly welcome new members from Local Civil Society Organizations (LCSOs). With sights set on the end of 2024, the meeting focused on identifying top RAI priorities in Laos and crafting action plans for the CoP itself. Members delved into key roles the CoP can play advancing responsible investment agriculture, and collaboratively laid out concrete plans for achieving them throughout 2023-2024. The discussion also embraced fostering the LCO community, understanding their building needs, and confirming continued membership in this growing network.










#### **Legal Calendar 2023 Taskforce**

#### **ToT on Legal Calendar 2024**

Between 08 - 10 November, 2023, LIWG organized a training of trainer on "dissemination of the Legal Calendar 2024" for the PIASVC project, which was led by the trainer team from the LIFE project with co-trainners from MCC and PSNUA. This training focused on different topics from the legal calendar 2024. Moreover, the participants exchanged about situation and issues while implementing trainings at actual sites. The most important thing was that the participants demonstrated a training with feedbacks from other participants and the trainers.



#### **Legal Calendar 2024 Launching Event**

On November 30, 2023, the opening ceremony of the 2024 Legal Calendar Launching Event was held at the Meeting Room of Training Center of Lao Front for National Development in Vientiane Capital. The meeting was chaired by Ms. khankham Douangila, the LIWG SC and were participated by various government sectors, CSOs and the press media. The event aimed to disseminate basic legal information drawn from various legislations to encourage individuals and all stakeholders to engage in sustainable development, contribute to publicizing regulations, requirements, and laws established by the party and the state, enabling the public to recognize, understand, and proactively implement them, as stipulated in Article 6 of the Constitution, provide promotional support for local government agencies in utilizing media to spread awareness about land management, natural resources, and the environment, improve accessibility of information for those in remote areas etc.

These efforts will ultimately help reduce misunderstandings or conflicts that may arise between investors and local communities impacted by various development projects."





**Land Sub-sector Working Group Meeting** 



on November 17th 2023, the second meeting in 2023 of Land Sub-sector Working Group was organized and chaired by Mr. Virana Sonnasinh, Director General of Department of Land, MoNRE. Co-chairing alongside Mr. Sonnasinh were Mr. Jesper Elias Lauridsen, representing Helvetas/LIWG, and Ms. Annette Schramm, representing GIZ. This aimed to tackling crucial topics like land-finance linkages, project updates, and forest land rights recognition. Over 50 participants delved into tax collection challenges, discussed the Country Action Plan for forest land rights, and brainstormed ways to strengthen intersectoral collaboration. Recognizing land's cross-cutting

nature, the LSSWG emphasized closer ties with the Natural Resources Working Group and contributions to the 9th National Socio-Economic Development Plan. The meeting prioritized knowledge exchange and collaboration between partners, paving the way for a more coordinated and impactful land sector in Laos.

#### **Country Action Plan on the Tenure Rights in Forest in Lao PDR**

LIWG had the opportunity to provide comments on the Country Action Plan (CAP) for the Tenure Rights in Forest which was collaboratively developed by the Ministry of Natural Resources, Department of Land, the Ministry of Agriculture and Forestry, Department of Forestry, Department of Agricultural Land Management, and the Department of Forest Inspection, throughout 2023, with the support of PROGREEN through the World Bank. The document describes the government's plan and approach to recognize and formalize the land use rights of all 3,167 villages located in the three categories of state forestlands (Conservation, Protection and Production forests).

#### Laos aims to become electricity source of Southeast Asia

Laos is making efforts to increase electricity exports to neighbouring countries in Southeast Asia and promoting the development of renewables, with the hope of becoming "the battery of Southeast Asia" in the near future.


According to data from the Ministry of Energy and Mines of Laos, the country currently has 94 power plants, including 81 hydroelectric ones, with a total installed capacity of more than 11,600 MW.

In 2022, electricity exports brought in over 2.3 billion USD in revenue for Laos, while the country had to spend just more than 40 million USD on electricity imports. The 9th ASEAN Ministerial Meeting on Minerals (AMMin) was held recently in Phnom Penh with the theme of "Promoting ASEAN as a Sustainable Minerals Investment Destination".

The meeting adopted a declaration on promoting ASEAN as an investment destination for sustainable minerals development, which highlights ASEAN's shared commitment to develop its mineral resources and contribute to securing an adequate and steady supply of metals and minerals to meet rising minerals demand and to fuel industrial expansion across ASEAN while encouraging responsible sourcing of mineral inputs and products to boost the region's... ## **COP28 Ends With Historic Deal to 'Transition Away' From Planet-Warming Fossil Fuels**

The COP28 climate talks in Dubai ended in a historic deal that committed the world to a transition away from all fossil fuels for the first time.

The president of this year's U.N.-sponsored summit, the UAE's <u>Sultan Al Jaber</u>, brokered an agreement that was strong enough for the U.S. and European Union on the need to dramatically curb fossil fuel use while keeping Saudi Arabia and other oil producers on board.

#### In Laos, forest loss and carbon emissions escalate as agriculture intensifies

As the government of Laos continues to prioritize a hydropower-heavy agenda to generate export revenues while striving toward greenhouse gas emissions reduction targets, it may be overlooking soaring carbon emissions from intact forest loss right under its nose.

A <u>new study</u> published in Environmental Research Letters indicates a recent expansion and intensification of shifting cultivation in Laos, resulting in direct loss of forests, degradation of important carbon sink ecosystems, and substantial increases in carbon emissions.

#### UK, Australia Boost Laos' Green Energy with Floating Solar Workshop

Laos, with support from the British and Australian governments, is gearing up to boost its renewable energy initiatives after a three-day workshop focusing on floating solar technology.

Organized by the United Kingdom's Mission to ASEAN and the British Embassy in Laos, the event, from December 11 to 13, aimed to boost the capabilities of the Lao Holding State Enterprise (LHSE), a state corporation primarily engaged in financing the energy industry, in implementing vital floating solar projects.
